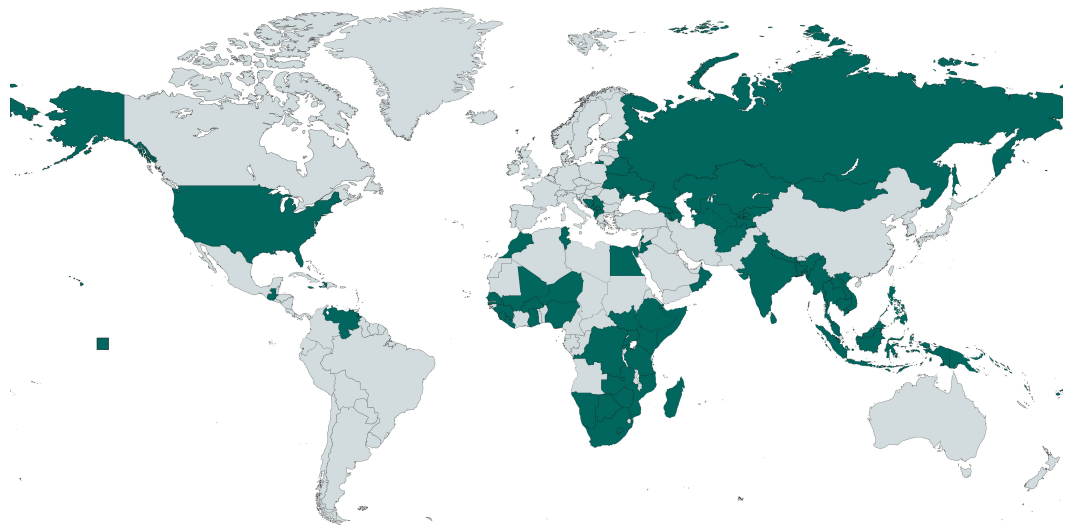
ABOUT US

PROJECT HIGHLIGHTS

PRIVATE SECTOR DEVELOPMENT

- **Economic Development, Governance, and Enterprise Growth (EDGE):** Implemented in partnership with the Europe and Eurasia (E&E) Bureau, EDGE connects with local enterprises to spur economic growth across 12 countries.
- **EDGE Buy-In:** The EDGE Buy-In supports supplemental activities as part of the EDGE project. A notable example is the privatization of state-owned enterprises in Ukraine that led to the successful auction of the Dnipro Hotel in Kyiv.
- **Supporting Accelerated Investment in Sri Lanka (SAIL):** This initiative supports streamlining the investment process by implementing activities focused on the tourism, labor, and trade sectors.

PUBLIC FINANCIAL MANAGEMENT

- **Indo-Pacific Opportunity Project (IPOP):** Awarded under the PFM II IDIQ, IDG works to provide the Asia Bureau and Missions with a flexible, on-demand mechanism to facilitate rapid, sustainable, and equitable economic growth by enabling USAID to bring a systems approach to addressing Public Financial Management (PFM) objectives under the Indo-Pacific Strategy.
- **Financial Sector Transparency Activity (FSTA):** The FSTA project in Moldova supports economic growth by combating financial crimes and systemic money laundering in the banking sector by automating shareholder transparency monitoring and building the capacity of the regulatory agencies.

INTERNATIONAL TRADE/ BUSINESS ENABLING ENVIRONMENT

- **Feed the Future Bangladesh Trade Activity:** By working with the government of Bangladesh through providing technical assistance and strengthening institutions, this project bolsters economic growth and food security, as well as enhances private sector competitiveness and facilitates trade.

MONITORING, EVALUATION, AND LEARNING (MEL)

- **Roads Evaluations:** IDG has partnered with MCC for over three years on conducting performance evaluations and estimating the economic return rate (ERR) of roads built by the agency in Cabo Verde, Liberia, Mongolia, Moldova, Mozambique, Niger, and Philippines.
- **Learning, Evaluation, and Analysis Project (LEAP II):** Completed in 2018, IDG with 4 international subcontractors, and numerous local partners implemented 36 activities in 30 countries to provide economic analysis and MEL services to the USAID Bureau for Economic Growth, Education, and Environment (E3).
- **Evaluation and Monitoring (EVAL ME IDIQ):** Awarded in Fall 2020, IDG brings together many subcontractors and 40 local research partners from across the globe.

- **Food Security Service Center (FSSC II):** To support the Feed the Future initiative and USAID's Global Food Security Strategy, IDG provides technical assistance in food security from nutrition and climate resilience to program design, M&E, research, and capacity building.
